

HUAWEI Developer Website Terms of Use

1. Website Ownership and Your Consent to the Terms of Use

The HUAWEI Developer Website Terms of Use (hereinafter, the "Terms of Use") apply to the Huawei websites at <https://developer.huawei.com/consumer> (hereinafter, the "Website" or the "Platform"). The Website is created, maintained, provided, and owned by Huawei (hereinafter, "Huawei", "we", "our", or "us", as the context may require), and its licensors. BY USING THE WEBSITE, YOU AGREE TO THE TERMS OF USE. IF YOU DO NOT AGREE TO THE TERMS OF USE, YOU SHALL NOT USE THE WEBSITE.

Although the Website is accessible from multiple countries and regions around the world, not all functions, products, or services discussed, mentioned, supplied, or provided on or via the Website are available to all persons or in all geographical locations.

We reserve the right, at our own sole discretion, to amend, modify, add, or delete any of the Terms of Use at any time. We recommend that you regularly check the changes to the Terms of Use. By continuing to use the Website after the changes have been posted, it will be deemed that you accept and agree to such changes. We will continue to grant you personal, non-exclusive, non-transferable, and limited privileges to enter and use the Site if you agree to comply with the Terms of Use.

You agree that if we conclude that you have violated the Terms or other agreements or guidelines when using the Website, we may, at our own discretion, terminate your access to the Website and/or terminate your access of the Website without prior notice to you.

2. Website Content

The Website and all the content thereof, including but not limited to texts, images, music, videos, animations, trademarks, patterns, charts, visual interfaces and coding, as well as the creation, design, structure, expression, and display of aforementioned content, are properties of Huawei, and are subject to the control by Huawei, or are used by Huawei with legal authorization. Unless otherwise expressly stated herein, you may not use the content of the Website for any commercial purposes in any manners without Huawei's prior written consent. You may download the information about Huawei's products and services provided by Huawei, provided that:

(1) you use such information only for personal purposes rather than commercial purposes, and you do not copy or release any such information on any networked computers or disseminate any such information via any form of media; (2) you do not modify any such information; (3) you do not make any further representation or warranties on such information or any documents containing such information; and (4) you do not remove any statements or notices indicating Huawei's legal rights and interests.

3. Your Use of the Website

You warrant that your use of the Website does not violate any applicable laws, regulations, policies, universally accepted customary practices, or pertinent provisions or guidelines of relevant jurisdictions, and does not infringe upon any third party's legitimate rights and interests (including but not limited to the right of privacy, intellectual property rights, right of reputation, right of portrait, and trade secrets).

You may neither access, obtain, copy, or monitor any part or content of the Website by using any device, program, or algorithm, including spider, robot, deep-link, and page-scrape, nor access, obtain, or copy any material, document, or information on the Website in any way that is NOT provided by the Website.

You may not take actions that store unreasonable or disproportionate amount of data on the infrastructure, system, or network of the Website, or systems or networks that link to the Website.

You undertake not to publish or transmit the following inappropriate content on or via the Website, including but not limited to:

- content that is defamatory, obscene, offensive, hateful, or inflammatory;

- content that promotes violence based on race, gender, religion, nationality, disability, sexual orientation, or age, or on any other grounds, and pornography;
- content that violates intellectual property rights;
- content that is or may be false, deceitful, or misleading;
- content that encourages, advocates, fuels, or assists in any illegal activity;
- content that threatens, abuses, or infringes upon third-party privacy;
- content that you know or believe, or have reasonable grounds to believe, that its publication is directed at or will be directed at the target public and may be understood to directly or indirectly encourage or induce them to commit, prepare for, or incite terrorism.

Huawei may, at any time and at its own discretion, block, delete, or modify the content or information that violates any of the preceding warranties, block or delete your HUAWEI ID, or completely cancel or block your privilege to access the Website.

You shall observe the Policy Center herein when you use the services provided by Huawei, including but not limited to the distribution, promotion, joint operation, and advertising services.

4. Account, Password, and Security

You may need to register/log in to your HUAWEI ID in order to use certain functions or services on the Website. You shall be fully responsible for safeguarding the information about your HUAWEI ID, including the password thereof, and be responsible and liable for any and all actions that occur via your HUAWEI ID in the event that you fail to safeguard said information.

You shall inform Huawei without undue delay of any abnormality in your HUAWEI ID, including but limited to your password being changed or others logging in to or using your HUAWEI ID without your authorization. If you fail to keep confidential of your HUAWEI ID information and as a result, your HUAWEI ID is used by others and Huawei or other users of the Website suffer a loss, you may be held liable to compensate Huawei or other users for such loss. You may not use the HUAWEI ID of others without the HUAWEI ID holder's explicit written permission and consent. Huawei does not assume any liability for your or other's loss incurred by you not observing this provision.

5. Violation of the Terms of Use

You shall agree to the following conditions:

- If we believe that you have violated the Terms of Use and/or other agreements and guidelines while using the Website, we may terminate and/or block your access to the Website without providing any prior notice and at our sole discretion;
- Any violation of the Terms of Use by you is deemed as an unlawful and unfair business practice causing irreparable harm to us. In such an eventuality, monetary compensation will be inadequate, and instead we will be entitled to injunctive or equitable relief based on what we consider to be suitable; and

If we pursue legal action against you in the event that you violate any of the Terms of Use, you agree that we have the right to recover attorney's fees and applicable costs, and that you will pay such fees and costs as well as other relief to us. You also agree that you or any third party will not hold us liable for terminating your access to the Website following such violations of the Terms of Use.

6. Disclaimers

Huawei does not make any warranty regarding the availability, continuity, and accessibility of the Website, its content, or its services. Huawei provides the Website and the content thereof on an "as-is" and "as-available" basis. You shall bear any and all responsibilities and liabilities for your use of the Website and any and all websites linked thereto. If you are not satisfied with all or part of the Website, you can contact us at [Customer Service](#). If we cannot satisfy your requirements, your only remedy is to stop using all or part of the Website's services. Such restriction of remedy shall be an integral part of the Terms. The full and maximum liability that Huawei and its partner assume for you for any and all damages or losses incurred by your use of the Website does not exceed the greater of (i) Euro €500; or (ii) the total amount of the subscription fees or similar fees that you pay for the use of the services or functions of the Website in the six (6) months before the event which caused such actual loss of yours. 8. Indemnification

9. Independent Remedies

To the maximum extent permitted by applicable laws, both the provisions of the "Limitation of Liability" and "Indemnification" herein shall apply, regardless of whether the cause of loss is:

- (1) breach of contract;
- (2) breach of warranty;
- (3) mistakes or infringements, including negligence and misrepresentations;
- (4) strict liability; or
- (5) any other reason.

11. Governing Law and Dispute Resolution

11.1 If you are visiting this Website in the Chinese mainland that is specified in part I of Exhibit A, this Website is provided by Huawei Software Technologies Co., Ltd. You agree that the establishment, jurisdiction, and interpretation of the Terms of Use shall be

governed by the laws of the People's Republic of China. You agree that this Agreement is signed in Longgang District, Shenzhen, P.R. China. Any and all disputes, compensation claims, and causes of action arising out of or in relation to the content and enforcement of the Terms of Use shall be resolved in the court with jurisdiction over the place where this Agreement is signed.

11.2 If you are visiting this Website in a country or region that is in part II of Exhibit A, this Website is provided by Aspiegel Limited. You agree that the establishment, jurisdiction, and interpretation of the Terms of Use shall be governed by the laws of Ireland. You agree that any and all disputes, compensation claims, and causes of action arising out of or in relation to the content and enforcement of the Terms of Use shall be submitted to the Irish Courts with jurisdiction in Dublin, Ireland, for litigation in the English language, without applying the United Nations Convention on Contracts for the International Sale of Goods.

11.3 If you are visiting this Website in a country or region that is in part III of Exhibit A, this Website is provided by Huawei Services (Hong Kong) Co., Limited. You agree that the establishment, jurisdiction, and interpretation of the Terms of Use shall be governed by the laws of Hong Kong (China), you agree that any and all disputes, compensation claims, and causes of action arising out of or in relation to the content and enforcement of the Terms of Use shall be submitted to the courts in Hong Kong (China) for litigation in the English language, without applying the United Nations Convention on contracts for the International Sale of Goods.

12. Miscellaneous

The Terms shall constitute the entire agreement between you and Huawei regarding the use of the Website, and shall supersede any and all prior written and oral agreements concluded by and between you and Huawei with regard to said subject matter hereof. With the exception of what is stipulated in other signed agreements between you and Huawei, Huawei does not accept any counter-offers against the Terms. If any provision of the Terms of Use is held to be invalid for any reason, such invalid provision shall not affect the validity of other provisions, and such invalid provision shall be deemed to have ceased to exist from the outset.
